

# **GDPR PRIVACY NOTICE**

This Privacy Notice applies to the website <a href="www.CovalisCapital.ky">www.CovalisCapital.ky</a>, as well as any subdomains and any other websites on which this Notice is posted, and any content from or through the websites operated by Covalis Capital LLP of 2<sup>nd</sup> Floor, 11 Charles II Street, London SW1Y 4QU ("Covalis Capital", "we" or "us"), and which is the Data Controller of the personal data provided via this website ("Personal Data"). This Privacy Notice describes how Covalis Capital collects, uses, shares and secures the personal information you provide via this website (i.e. by email). It also describes the choices available to you regarding our use of your Personal Data and how you can access and update this information.

# 1. Personal data we may collect

In order to provide you with information about Covalis Capital and its funds and associated investment opportunities it may be necessary for Covalis Capital to process certain personal information such as names, telephone numbers and email addresses and any personal identification documents you supply in order to confirm your identity and circumstances.

Covalis Capital may collect a variety of Personal Data via any email address listed on the website. This Personal Data may include information such as name, email address, mailing address, phone number.

We may use this information for our legitimate business interests, including to:

- send you requested business, product or service information;
- respond to queries and requests;
- administer and manage delivery of our services and products to you; and
- comply with our legal and regulatory obligations.

## 2. How we collect this data

Covalis Capital may collect personal data through a range of means. These may include:

- direct interactions (where you provide personal data to Covalis Capital via telephone
  or email correspondence or other direct methods of communication, including
  applications to invest in Covalis Capital 's funds or for prospective employment);
- from third parties such as intermediaries and banks in the case of prospective investors or third party recruitment firms in the case of prospective employees; and/or
- other publicly available sources (such as websites (for example, LinkedIn), or online registers (for example, FCA or other regulatory registers).

#### 3. Information Sharing

We will only share your Personal Data with third parties in the ways set out in this Notice.



We do not sell your Personal Data to third parties for them to market their services to you. We may provide your Personal Data to our service providers to help us with our business activities. In all cases we will have a written data processor agreement with these companies safeguarding your Personal Data, including that it may only be processed for the purposes of that agreement and on our instructions.

We may also disclose your Personal Data:

- as required by law, such as to comply with a subpoena, or similar legal process;
- as permitted by law, such as when we believe in good faith that disclosure is
  necessary for our legitimate interest such as investigating fraud, to make or defend a
  legal claim, to protect your safety or the safety of others, or to maintain our
  compliance or that of our personnel with applicable laws and regulatory
  requirements, in accordance with applicable law; and/or
- in other situations, only with your prior consent.

#### 4. Transfers outside the EEA

We may transfer your Personal Data to service providers or other entities outside the European Union for the purposes set out in this Notice. We will put in place appropriate measures to safeguard Personal Data transferred, and by providing your Personal Data you consent to such transfer.

# 5. Your Rights

You have the right to ask whether Covalis Capital processes your Personal Data and to request a copy, to object to direct marketing and in certain circumstances to have the data rectified or blocked. # 6. Cookies and Website Analytics

Covalis Capital does not collect cookies or use any other means (e.g. website analytics) which may serve to directly or indirectly identify you.

# 7. Security

No method of transmission over the Internet, or method of electronic storage, is 100% secure, however. # **Telephone Recording**
